1. Introduction

Jointly with NCC's values, this Policy forms the foundation for our effort to create a healthy and safe work environment. Think safe – Work safe – Be safe.

2. Policy Statement

2.1. Scope

This Policy applies to all NCC employees and it is the responsibility of NCC manager to improve the work environment. All NCC employees, partners and suppliers must act in a safe manner and always take health and safety issues into account.

2.2. Zero Vision

Our vision for health and safety is "Zero accidents."

2.3. Strategy

We will achieve our vision and create a healthy and safe environment through:

- Commitment and consideration Each and every employee has a personal responsibility to be committed to and involved in the creation of a healthy and safe workplace, to act safely and to take "Time Out" if they observe risky or unsound behavior in the workplace.
- Right products and methods Products, stakeholders and methods must always be selected with due consideration for health and safety.
- Risk awareness The risk of accidents and injuries should be reduced through continual mapping of root causes in the design, planning and validation phases, of all work. The objective is to minimize the risk potential and share best practices at the earliest possible stage. This applies particularly to high-risk jobs such as work at height, heavy assembly work and work carried out in a traffic environment.

 - ensure the adequacy of the content of this Policy and propose changes and revisions when needed,
 - ensure the Policy is appropriately communicated,
 - monitor understanding and adherence to the Policy, and
 - respond to known or reported violations of the Policy.
- The primary target audience of this Policy comprises business area managers and heads of staff functions who are responsible for enforcing the Policy and thus need to have in-depth knowledge of it.
- Procedures in the event of non-compliance are outlined in NCC's Code of Conduct.
